We will be using outdoor and indoor sections of the resort. This is a working resort and there will be general public throughout the grounds. Please keep dogs out of the check in / secretary area unless you are queuing for a search area.

Please be sure to read any posted signs for important information!

Check-In / Secretary / Search Areas:

We are meeting with the judges on Thursday in order to finalize search areas and the best spot for secretary, ribbons, check-in, etc. Once this information is finalized it will be posted on the Matrix website event page, on the FRSWC facebook page, and through the text messaging system (info on that is below). We will also have resort maps with the search areas noted.

Parking/Crating:

Crating will be out of your vehicles/RV/cabins. We are working on an area that we might be able to set up canopies (at your own risk). Be sure to not block vehicle access. Remember this is a working resort. Vehicles and any tents/awnings/chairs etc MUST fit in a legal parking spot.

Wait-List & Pulled Entries:

As of the posting of this document, there is plenty of availability for all days. To check for run availability, see the Matrix Dog website event page under the "Current Run Availability" section, which will be updated as needed until the first day of the trials.

Refund policies are listed in the premium.

Absent dogs <u>must be declared in writing</u> in order for spots to be eligible to be filled by the waitlist. We will not pull dogs from the trial without notice being given in writing.

Running Order:

The exact running order will be fluid and dependent on weather, conflicts, worker dogs, etc. Pre-entry counts are listed below. If you are running multiple dogs and you aren't sure where to go first, ask! If you need a break between your two runs in a set, just let us know.

Friday/Saturday/Sunday:

8:00am – Check-in opens (You do not need to arrive first thing in the morning to check in.) 9:00am – Briefing, Walk Throughs (grouped as per the below), first dog to follow. See schedule below. Other breaks may be taken at the judge's and/or club's discretion.

Interior searches may have a few (~5) stairs, with a handrail, to access the search area. If this is an area of concern, please contact us BEFORE FRIDAY to discuss further.

The judge for Advanced Buried/Container has been changed to Dr John Strassner for Fri/Sun and Maureen Baumtrog for Sat. Exhibitors have the right to pull and request a full refund of their entry fee for any classes affected by this change. Exhibitors must submit requests in writing to the Trial Secretary a minimum of 30 minutes preceding the start of the event on the first day in which the exhibitor is entered.

Next day move-ups are offered. Move ups for the next day must be in writing to the Trial Secretary no later than 30 minutes after the last dog finishes that class.

Miscellaneous Notes:

Water is available but if you can please bring water jugs for dog water.

Dogs must be kept on lead in keeping with the leash laws. Please also remember to respect other people's property!

Pottying: There are plenty of grass and rock areas around the entire grounds. There are also three fenced in dog parks (see resort map). Dogs should not be off-leash unless in a fenced area or as allowed while searching. You must pick up after your dog or you risk being excused from the trial. Pay attention to marked areas so you aren't walking into a search area. Be sure to pick up after your dog. Please keep your dog from peeing on the side of the building, garbage cans, etc or on any items that people have to pick up! Clean up any accidents immediately. BE RESPECFUL TO THE PROPERTY AND GROUNDS!

Food/Drinks: There are several restaurants on the grounds. There is also a Grocery Store nearby: City Market 1001 Thompson Rd, Granby, CO 80446 (7 minutes, 3.3 miles from Sun Outdoors).

Bathrooms: There are numerous bathrooms on site – every building plus the comfort stations as listed on the resort map.

Cabins & RVs:

Sun Outdoors Rocky Mountains has both RV and Individual Cabin spots on site. There is a block reserved for the event at a discounted rate which will be available until 30 days prior to the event. The rates listed below were the block rates and are subject to change after the block closes.

Cabins:

*Studio Cabin (Mini Fridge/Microwave, king bed & sleeper sofa - ARROWHEAD): \$150 per night *Studio Cabin (Mini Fridge /Microwave, king bed & sleeper sofa plus queen in loft - FOXTAIL): \$150 per night

*2 Bedroom Cabin (Full Kitchen, queen bed, full/twin bunks, & sleeper sofa – BEARCLAW): \$175 per night

There is a \$50 Pet Fee per stay for cabins.

RV Spots:

*Full Hook-Up Standard Back-In RV Sites: \$70 per night.

All reservations (cabins & RVs) will be charged a \$10 per day Resort Fee plus 10% in Taxes.

GOLF CARTS ARE AVAILABLE TO RENT. MENTION WHEN BOOKING STAY.

\$60 per day for a 4-seater and \$80 per day for a 6-seater.
