Wait-List & Pulled Entries:

As of 3/13, there is a small waitlist for upper levels on Saturday. If you need to pull you may receive a refund/credit as per the policy listed in the premium. We will NOT be substituting entries for handlers who do not check in, you will be marked as absent if you miss your runs and the class closes out. Written notice (email or in person) must be given by 7am on the morning of the trial for all pulled entries in order to be eligible for a refund. See the premium for more information on the pull & refund policies.

If applicable, we will shut down the pre-trial wait-list at 11:59pm on Thursday. After that, if you are on the waitlist, you are welcome to show up the morning of the trial to see if there are any last minute pulls from Friday / after. It is not guaranteed that pulls will be able to be replaced by a waitlisted run. It is not guaranteed that there will be runs available for waitlisted dogs on the day of the show. But What Time Will My Class Start?

We get a lot of questions on "when will my class start" for trials. We cannot give out times other than the start of the first class of the day. However, here is a way for you to estimate when your class MAY start running:

In the Regulations for AKC Scent Work (on the AKC website under "Scent Work" "Regulations Resources"), page 18 under Chapter 3 Section 22 it lists an estimated time per entry per class/level.

Above, we give entry counts as of the pre-entry closing along with the order the classes will run.

You can multiply out the estimated judging time per run x the entries in each class to get a rough estimate. However, please note that this doesn't include absent dogs, move-ups, day-of-show/late entries, judge breaks, lunch breaks, etc. And runs don't always last the "estimated" judging time per run. There are no refunds/credits/moves for missed runs. Calculate at your own risk!

Text Message Alerts:

Receive informational text messages regarding Front Range Scent Work Trials!
(Including what classes we are currently building/running.)

- You will receive a text message asking to provide your full name.
- If asked “Are you a teacher, parent, or student” – text reply “S” for student.
- Make sure you are at least 13 years old if you make up a birthday. 😊
- Then your phone will receive text messages of interest during the event.

You do NOT have to download or utilize the software link suggested to receive our text messages on your phone!

*This text messaging system is primarily used by educators, so it may reference “classes”, “teachers”, and/or “students”.

Miscellaneous Notes:

The buildings are climate controlled. Power is not guaranteed.

Water is available in the bathrooms but if you can please bring water jugs for dog water.

All **crates** must have a towel/tarp/blanket between them and the floor to protect the flooring.

Depending on the weather, crating space may be limited. Please pack light. We reserve the right to limit individual crating space.

You are welcome to bring **chairs**.

Dogs must be kept on lead in keeping with the leash laws. Please also remember to respect other people's property!

Potting: There are some grass/mulch areas/fields outside the building. Pay attention to marked areas so you aren't walking into a search area. Please be sure to pick up after your dog. Please keep your dog from peeing on the side of the building, or on any items that people have to pick up! Please clean up any accidents in the building immediately.

Food/Drinks: There is a Walmart, Marco's Pizza, McDonald's etc 2.5 miles / 6 min from the fairgrounds.

Bathrooms: There are bathrooms on site in each building.

Directions to the Trial Site:

From Denver

Take I-25 N to I-76. Take I-76 to U.S. Highway 85 N to 124th Avenue. Turn west on 124th Avenue and go one mile to the entrance of the Regional Park Complex.

From Ft. Collins

Take I-25 S to Highway 7. Take Highway 7 east to U.S. Highway 85 in Brighton. Take U.S. Highway 85 S to 124th Avenue. Turn west on 124th Avenue and go one mile to the entrance of the Regional Park Complex.

Local

Take 120th Avenue to Quebec. Turn South on Quebec to Riverdale road, turn North. Take Riverdale road to 124th Avenue and turn East. The Regional Park Complex is 1/4 mile on the left.

Alternate Local

Take 128th Avenue east to Riverdale Road. Take Riverdale Road south to 124th Avenue. Take 124th Avenue east. The Regional Park Complex is 1/4 mile on the left.

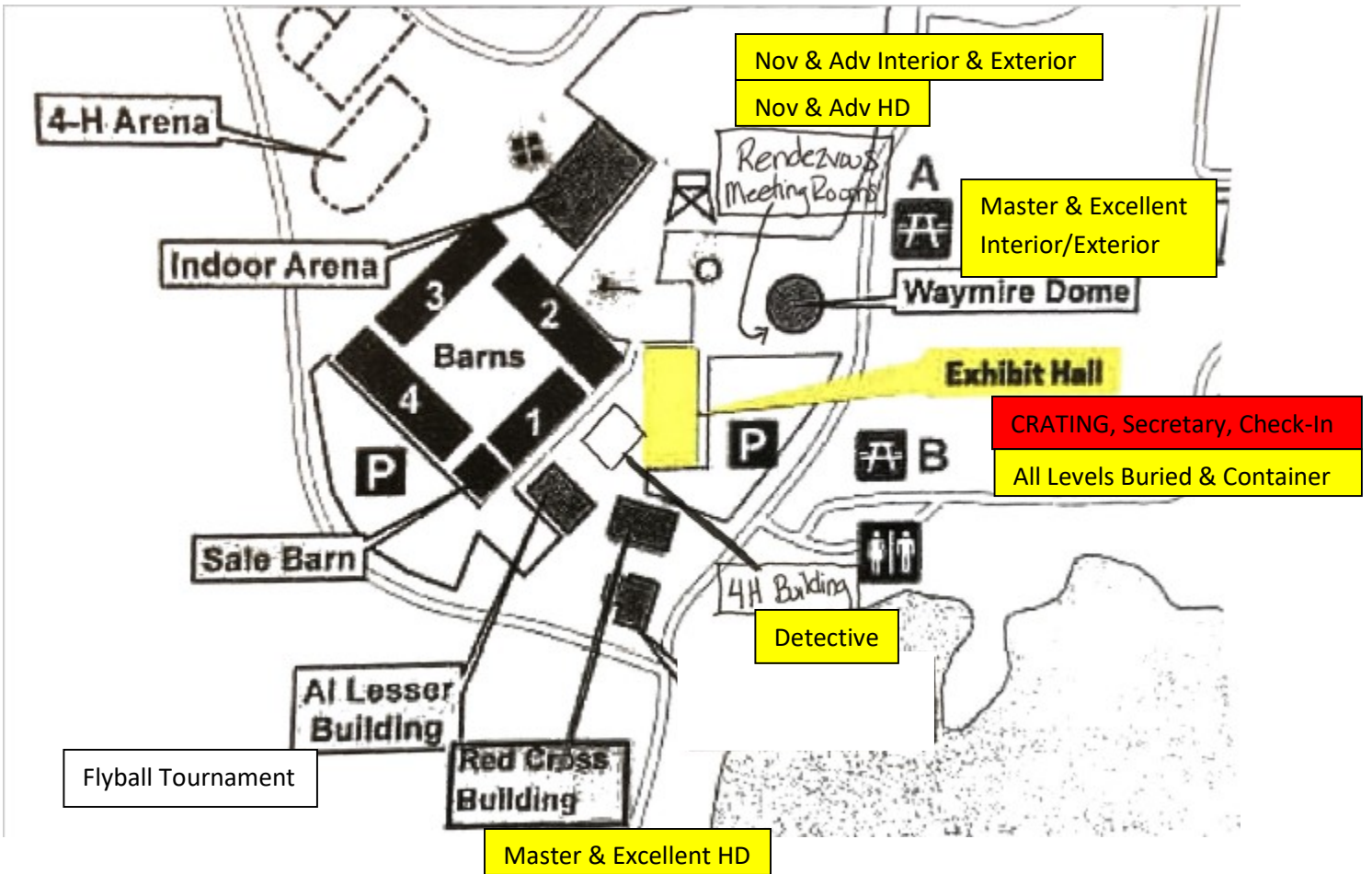

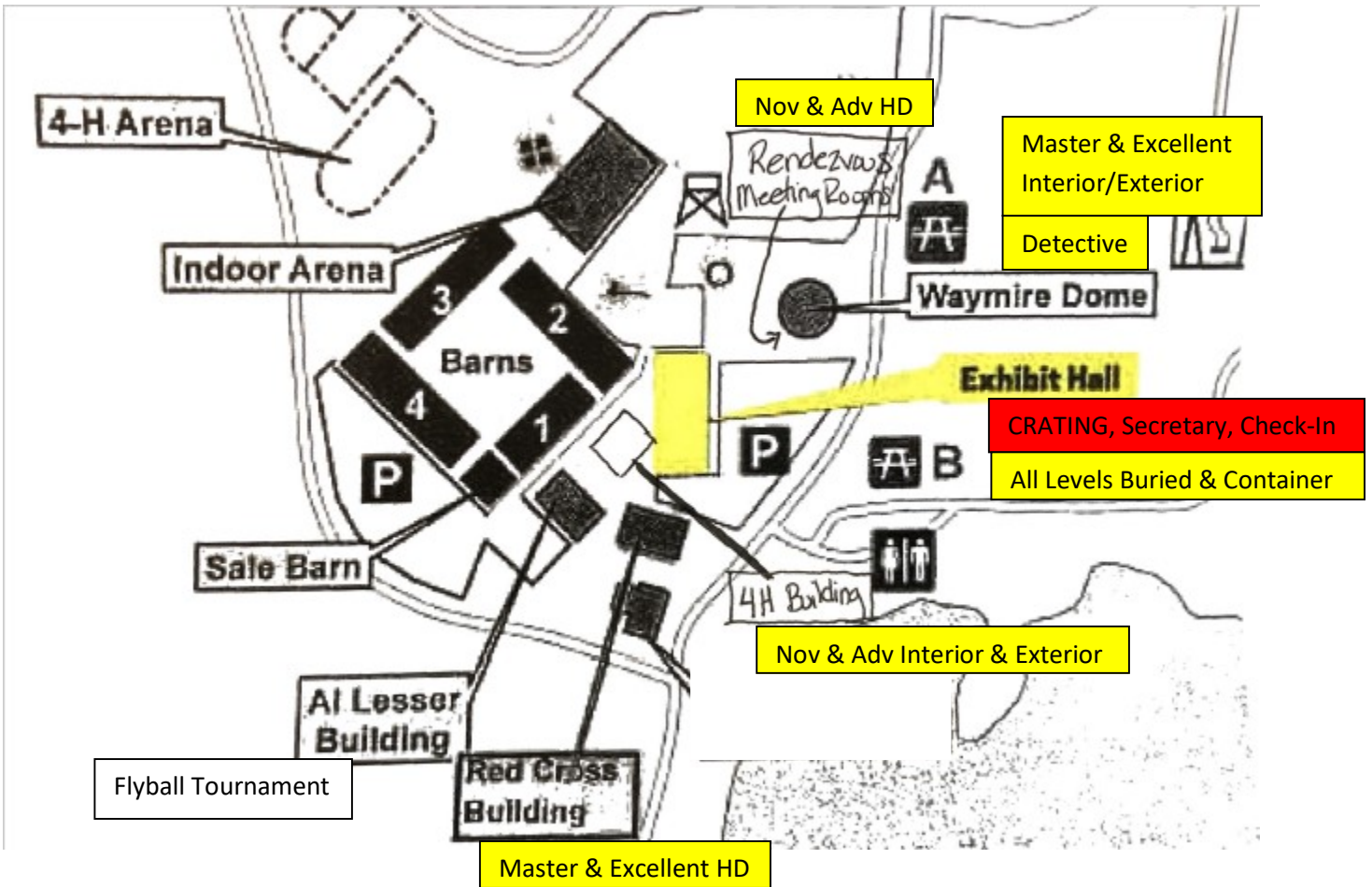
