Saturday Advanced Container and Advanced Buried are now being judged by Jessica Taylor. Exhibitors have the right to request a full refund of their entry fee for any classes affected. Exhibitors must submit those requests in writing to the Trial Secretary a minimum of 30 minutes preceding the start of the event on the first day in which the exhibitor is entered.

## Crating:

Our current plan is to have **indoor crating available for entrants after Nov/Adv Interior Friday morning, in the 4H Building**. You can leave crates set up the rest of the weekend. It will most likely be tight so please plan on stacking crates etc. We reserve the right to rearrange spaces to fit additional crates as needed. **All day workers** can crate inside Friday morning, as long as their dogs are not disruptive to the classes running. Please contact us if you'd like to help out as an all day worker (vouchers paid for working) – we can typically work around you running dogs!

If anyone has demo dogs available (especially for Detective on Friday, and Master classes all weekend), please let us know!

## Photographer:

Saturday - Inquisitive Photography (Nicole Mills) will be photographing dogs in novice and master exterior on Saturday depending on weather and judging schedule. Keep in mind that Nicole will be running her own dogs and cannot be everywhere at once. Please fill out a photo request form if you would like pictures of your dog! Filling out this form does not mean you are required to buy photos - it just means she will try her hardest to get lots of pictures of your dog! ## Schedule:

8:00am – 4H Building will open for check-in. **IMPORTANT: Crating space will not be available for competitors until after Nov/Adv Interior Friday morning.**

8:50am - General Briefing and Handler Briefings to follow.

Runs for each judge to start after handler briefings.

A lunch and other breaks may be taken at the judge's and/or club's discretion.

## Late/Day of Show Entries:

As of 1/28, there are a handful of runs available on Friday and Saturday, and Sunday has more room available. Late and day of show entries may be available depending on entry counts at the time. Day of show entries must be turned in no later than 1 hour before the start of the trials.

## Class Order:

The exact running order for dogs will be fluid and dependent on conflicts, worker dogs, etc. Pre-entry counts are listed on the next page.

## Wait-List & Pulled Entries:

As of 1/28, there is no waitlist. If you need to pull you may receive a refund/credit as per the policy listed in the premium. We will NOT be substituting entries for handlers who do not check in, you will be marked as absent if you miss your runs and the class closes out. Written notice (email or in person) must be given by 7am on the morning of the trial for all pulled entries in order to be eligible for a refund. See the premium for more information on the pull & refund policies.

If applicable, we will shut down the pre-trial waitlist at 11:59pm on Thursday. After that, if you are on the waitlist, you are welcome to show up the morning of the trial to see if there are any last minute pulls from Friday / after. It is not guaranteed that pulls will be able to be replaced by a waitlisted run. It is not guaranteed that there will be runs available for waitlisted dogs on the day of the show. It is not guaranteed that there will be runs available for dogs on the day of the show.

## ***But What Time Will My Class Start?***

We get a lot of questions on "when will my class start" for trials. We cannot give out times other than the start of the first class of the day. However, here is a way for you to estimate when your class MAY start running:

In the Regulations for AKC Scent Work (on the AKC website under "Scent Work" "Regulations Resources"), page 18 under Chapter 3 Section 22 it lists an estimated time per entry per class/level.

Above, we give entry counts as of the pre-entry closing along with the order the classes will run.

You can multiply out the estimated judging time per run x the entries in each class to get a rough estimate. However, please note that this doesn't include absent dogs, move-ups, day-of-show/late entries, judge breaks, lunch breaks, etc. And runs don't always last the "estimated" judging time per run. There are no refunds/credits/moves for missed runs. Calculate at your own risk!

### Text Message Alerts:

- You will receive a text message asking to provide your full name.
- If asked “Are you a teacher, parent, or student” – text reply “S” for student.
- Make sure you are at least 13 years old if you make up a birthday. 😊
- Then your phone will receive text messages of interest during the event.

You do NOT have to download or utilize the software link suggested to receive our text messages on your phone!

## Miscellaneous Notes:

The buildings are climate controlled. Power outlets are not guaranteed.

**Water** is available in the bathrooms but if you can please bring water jugs for dog water.

All **crates** must have a towel/tarp/blanket between them and the floor to protect the flooring.

**Depending on the weather, crating space** may be limited. Please pack light. We reserve the right to limit individual crating space and rearrange spaces as needed.

You are welcome to bring **chairs**.

**Dogs** must be kept on lead in keeping with the leash laws. Please also remember to respect other people's property!

**Potting:** There are some grass/mulch areas/fields outside the buildings. Pay attention to marked areas so you aren't walking into a search area. Please be sure to pick up after your dog. Please keep your dog from peeing on the side of the building, or on any man-made items! Please clean up any accidents in the building immediately.

**Food/Drinks:** There is a Walmart, Marco's Pizza, McDonald's etc 2.5 miles / 6 min from the fairgrounds.

**Bathrooms:** There are bathrooms on site in each building.

## Directions to the Trial Site:

### From Denver

Take I-25 N to I-76. Take I-76 to U.S. Highway 85 N to 124th Avenue. Turn west on 124th Avenue and go one mile to the entrance of the Regional Park Complex.

### From Ft. Collins

Take I-25 S to Highway 7. Take Highway 7 east to U.S. Highway 85 in Brighton. Take U.S. Highway 85 S to 124th Avenue. Turn west on 124th Avenue and go one mile to the entrance of the Regional Park Complex.

### Local

Take 120th Avenue to Quebec. Turn South on Quebec to Riverdale road, turn North. Take Riverdale road to 124th Avenue and turn East. The Regional Park Complex is 1/4 mile on the left.

### Alternate Local

Take 128th Avenue east to Riverdale Road. Take Riverdale Road south to 124th Avenue. Take 124th Avenue east. The Regional Park Complex is 1/4 mile on the left.

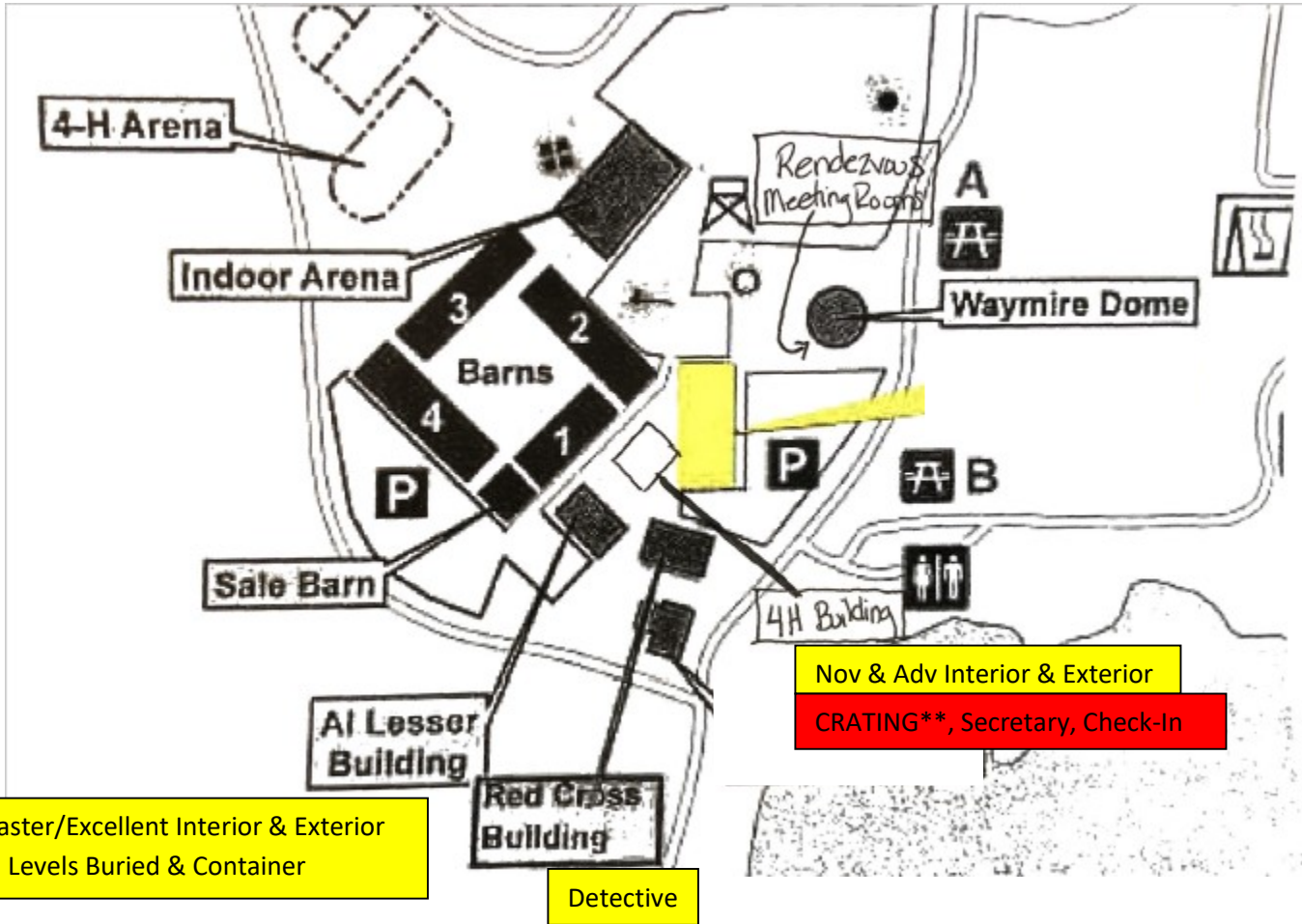
