ENTRY METHOD: FIRST RECEIVED

ENTRIES WILL OPEN ON **August 1, 2026 at 12:00 PM (noon) EDT for Samoyeds, and September 1, 2026 at 12:00 PM (noon) EDT for All Other Breeds** at the Event Secretary's address listed in this premium ONLY. All entries received before this date will be returned. Overnight or certified mail must be sent with the "No Signature Required" waiver signed.

EARLY ENTRIES CLOSE ON September 22, 2026 at 12:00 PM (noon) EDT after which time entries cannot be accepted, cancelled, altered, or substituted except as provided for in this premium and the AKC Fast CAT Regulation book. Envelopes/transactions containing entries for more than the ten (10) dog maximum and/or entries received prior to the opening date shall be treated as an invalid entry and shall be returned to the sender.

AKC REGISTRATION

All dogs must be individually registered with the AKC. This includes all AKC registered purebreds, Foundation Stock Service (FSS), Purebred Alternative Listing (PAL), and AKC Canine Partners. Spayed or neutered dogs, or dogs with breed disqualifications may be entered. Not AKC registered? NO PROBLEM! You will be able to register your Canine Partner with AKC at the event, and your dog can participate in the tests that very same day.

AWARDS

A light blue flat Q ribbon will be awarded to each dog that receives a qualifying run for the Fast CAT.

New Title Rosettes for BCAT/DCAT/FCAT will be available.

SAMOYED ONLY rosettes awarded daily for Fastest Female, Fastest Male, Fastest Veteran Female, Fastest Veteran Male. *(Only need to complete one run to qualify daily.)*

ENTRIES

All entries must be legible or they will not be accepted. Late, incomplete, unsigned, unpaid or conditional entries, or entries not containing the "Agreement" found on the Official AKC Entry Form will not be accepted.

BY MAIL: Complete an official AKC entry form for each dog (at the end of this premium). ONE ENTRY FORM PER DOG. A dog may only enter once per test (so twice per day). Mail completed forms with fees payable to Matrix Dog and send to 13120 Raritan Street, Westminster, CO 80234. Incomplete entries will be deemed invalid. Time slots will be assigned based on availability when the mail-in entry is received. *(Register online to see availability and pick your own time slot.)*

ONLINE: Online entries will only be accepted from event opening until the event is full. Visit <http://www.MatrixDog.com/>. There is an additional fee for online entry due to processing fees charged by the company (mail in entries do not incur this fee).

DAY OF TEST ENTRIES: Day of Test Entries for each dog: \$32, payable at the Event Secretary table, if space is available. Credit cards and cash accepted. Day-of runs will be fit in as space allows throughout the day. It may be a long wait. **Register before 1:00 PM each day.**

FUN RUNS will **not** be offered at this event.

WITHDRAWING ENTRIES & REFUNDS: No entry fee will be refunded if a dog is absent, disqualified, excused, or banned from competition by the action of the field committee. No entry fees will be refunded if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or its members and representatives.

Entry fees submitted and accepted will be refunded in full (transaction/processing fees are non-refundable) if the withdrawal of said entries are requested by the dog's owner or agent prior to the early entry closing deadline for entries. Requests must be made in writing to the Event Secretary. After early entry closing, there will be no refunds unless the entered dog upon inspection is lame, unfit to compete, or in season in which case their entry fees shall be refunded (transaction/processing fees are non-refundable).

No refunds will be given for missed runs and runs are not able to be moved to another day.

Bitches in season, or bitches which come in season after the close of entries, shall be barred from participating in the test and their entry fees shall be refunded (transaction fees are non-refundable). Notification to the Event Secretary of bitches in season must be made before or during roll call. Bitches known to be in season shall not be brought onto the trial grounds.

Substitution of dogs prior to check-in each day is allowed (please bring a completed entry form if the dog is not already entered).

A return check fee of \$50.00 will be assessed for any check(s) returned for insufficient funds.

Refunds will be processed within 10 days of the completion of the event.

CANINE PARTNER REGISTRATION

If your Canine Partner is not yet registered with AKC, simply fill out the Canine Partners Enrollment Application located at the end of this premium list and turn it in along with your entry form and fees (Payment is made directly to AKC. Fill out the credit charge authorization on the Canine Partners form or include a separate check for \$35 payable to AKC).

INSPECTION

At the time block check-in, each dog will be inspected by the inspection committee for lameness, fitness to compete, and females in season. All dogs to be inspected must be presented WITHOUT TAPE, BANDAGES, or WRAPPING/COVERINGS of any kind (Coats, blankets, etc.). If, in the opinion of the inspection committee, any entry is found to be lame, unfit to compete or in season, they shall not be allowed to test, and the applicable entry fees shall be refunded (transaction fees are non-refundable). Dogs must be presented for inspection again after their first run and before their second run.

ROLL CALL / CHECK IN

Handlers will be assigned a time block for each run. **If you register online, you can pick your time block!** During that time block, all dogs will rotate through. If you are running both tests of that day in the same time block, dogs will rotate a second time through after the first runs are done. Show up from 15 minutes before your block to up to one hour before your block closes to check-in and inspect for your first run. After your first run is completed, you will need to return to the inspection area for your second inspection before getting back in the queue for your second run. Each dog must be inspected prior to each run. Day-Of-Test runs will be fit in as space allows throughout the day. It may be a long wait!

Please check in for your run prior to close of your run window. If you aren't able to check-in for your window, we will make every effort to accommodate you in another window. Please understand that this will be on an availability only basis and no guarantee can be made there will be room. No refunds will be given if there are no later spots available. Runs are not able to be moved to another day.

RUNNING YOUR DOG

It is recommended that dogs be handled with a "slip-lead" that gives instantaneous freedom to the dog when the "Tallyho" (release) signal is called by the Huntmaster. The Host Club will have slip leads for you to borrow. Please ask.

The club may have helpers available to release dogs, but that is not guaranteed. Please have your releaser/catcher coordinated before your turn. The catcher should be down the field before it is your time to enter the lane, or the club may move onto the next dog.

Dogs may wear any collar except a choker collar, a collar with prongs or an electronic training collar. The collar should be snug to minimize the chances of getting hung up on something during the run. Owners should be aware that tags hanging from the collar could be required to be removed to help prevent them from being entangled on something during the run. Owners may use clips or rubber bands to hold the dog's hair. The owner assumes responsibility for the safety of the dog regarding the dog's collar and paraphernalia on the dog.

FAST CAT SUMMARY DESCRIPTION

The Fast CAT Test is a timed 100-yard dash for dogs. It is meant to be a fun and healthy activity of interest to any dog owner. The following is a summary of how the event is structured.
How Does Fast CAT Work?

Fast CAT is a timed straight race of 100 yards. Dogs run singularly.

The dog's time to complete the 100-yard dash is converted into MPHs.

A handicap system is applied to a dog's MPH to determine the number of points earned. The handicap system is based on the height of the dog at its withers:

- 18" or greater = handicap is 1.0
- 12" up to but less than 18" = handicap is 1.5
- Below 12" = handicap is 2.0

Points = MPH multiplied by the dog's handicap

Fast CAT titles suffix titles are earned at designated milestones:

- BCAT = 150 points
- DCAT = 500 points
- FCAT = 1,000 points
- FCAT# = every additional 500 points

Top 20 by Breed by Year: The AKC Fast CAT website will feature the Top 20 Fastest Dogs by Breed by Year national standings. The standings will be updated as event results are processed.

ELIGIBILITY TO PARTICIPATE

Open to all dogs at least 12 months of age that are individually registered/listed with the AKC. This includes dogs recorded in the FSS program, dogs with PAL numbers or dogs enrolled in the AKC Canine Partners program. Females in season may not enter. A dog may enter only once per event. (An event number defines an event.)

An inspection committee shall inspect each entry for lameness, fitness to compete and females in season. If necessary, the inspection committee is responsible for measuring dogs to determine their height at the withers.

COURSE / EQUIPMENT

Safety: Safety is of utmost importance. It is the responsibility of the event committee to ensure the safety of the course, the equipment and the conduct of those involved with the event. It is recommended that the event committee run a test dog prior to the start of the event to ensure that the equipment functions properly and all personnel understand their jobs. Prior to moving the lure to position it for the start, the lure operator shall announce, "hold your dogs" in order to caution owners.

The Start: Dogs may start up to a maximum of 10 feet behind the starting line. There will be a line on the ground indicating the 10 foot mark. Both front paws must be forward of the line on release.

The Finish: The club must provide enough room for a safe run-out area, which is a minimum of 30 yards. The course will be fully fenced. It is recommended that an owner or someone familiar with the dog stand at the finish to catch the dog once the course has been completed.

Timing Devices: The time to complete the 100-yard dash is recorded to the nearest 1/100th of a second (e.g. 9.11). The club will use break-the-beam equipment to obtain the time. If the timers

fail, stopwatches will be used, there shall be two timers positioned at the finish line. An individual at the start line shall signal with an arm drop the moment the nose of the dog crosses the start line. The timers shall start their stopwatches at the bottom of the arm drop. The timers shall stop their watches when the nose of the dog crosses the finish line. The times from the two stopwatches shall be averaged to determine the recorded time.

Lure Equipment: The event will be run with a continuous loop system. The lure operator and the lure equipment shall be safely positioned in a manner that does not interfere with the retrieval of the dog at the end of the course.

Lure: A white plastic bag will be used for the lure.

Course/Fencing: The course is essentially flat and the course area is fenced.

HUNTMASTER HAS CONTROL OF THE COURSE

The Huntmaster has control of the course and is in charge of all dogs and handlers on the field.

NOTICE TO ALL EXHIBITORS

Please ensure the comfort of you and your dogs by bringing your own portable shade/shelter and water.

For the safety of the dog and as a courtesy to other entrants, a testing dog should have a reliable recall. A penalty of \$5.00 may be assessed for any dog causing an excessive delay of the event because it cannot be recalled or retrieved from the field. Dogs that delay the event because their owners cannot recall them may be refused entry at future events.

The Huntmaster is responsible for field safety and therefore s/he is in complete charge of all dogs and handlers on the field. In service to this responsibility, s/he has the authority to stop the lure in any potentially dangerous situation and signal the handler to retrieve a testing dog. Listen to the Huntmaster and follow all instructions promptly and swiftly.

Any decisions made by the event's official(s) regarding the performance of an entered dog shall be final. Full discretionary power is given to the official (s) to withhold any and all qualifications for lack of merit. The official(s) is responsible for ensuring compliance with the AKC Regulations on the field.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

Coursing is an athletic activity that can tax a dog's physical strength. Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion. The inspection committee has the authority to disallow a dog's entry into a test, and in such instances, applicable entry fees will be refunded.

Persons exhibiting conduct detrimental to AKC/any dog(s) and/or other person(s) will be asked to leave the event grounds and no refunds will be given.

The event-hosting club, its agents, members, representatives, volunteers, etc., assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children or spectators.

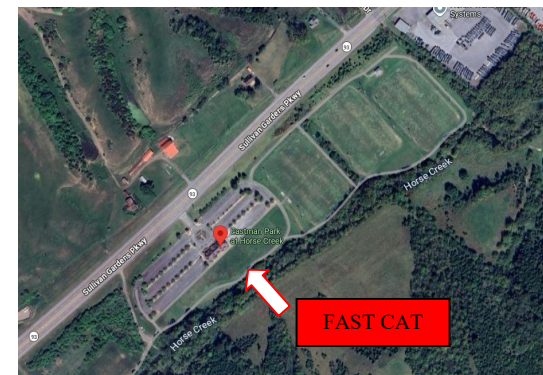
DIRECTIONS TO THE EVENT SITE
